# **Public Comment Themes**

Comments received in August reflected a variety of themes, with comments on Process, Transit, Tolling, and Funding & Financing having the highest frequency. Although not always in this order, these have been the top four comment categories since May 2009.

# Communications Summary August 2009

## Process

Comments about process covered a wide range of topics, including questions as to how outreach is occurring with the Latino community, when the Final EIS will be available, and whether the bridge toll survey would be used to optimize toll revenue.

## Transit

Light rail comments were the most frequent type of transit comment, including four comments supporting light rail, five opposing light rail, and seven comments and/or questions about light rail. Four comments were received debating which alignment – 17<sup>th</sup> or McLoughlin – would be in the best interest of the Arnada neighborhood.

## Tolling

Three commenters supported I-5 bridge tolls, twelve opposed them, and 16 had general comments or questions about them. Several tolling opponents cited concerns about the impact tolls could have on low-income commuters. In addition, support and opposition were expressed for tolling I-205 and for implementing electronic tolling. A Web-based tolling survey is ongoing. Early results will be available by Oct. 1.

## Funding and Financing

Though funding and financing issues covered many topics, six comments were received on the importance of funding a maintenance and security program should the replacement bridge's bicycle and pedestrian facilities be located inside the bridge structure. These comments came from bicycle and pedestrian advocacy organizations who had been asked for bridge design recommendations.
