Communications Summary May 2009

Public Comment Themes

Comments submitted in May reflected a variety of topics, with comments about Transit, Process, Tolling, and Funding and Financing having the greatest frequency.

Transit

Though a wide range of transit related comments were submitted in May, support and opposition to light rail were the most frequent. Supporters (six comments) said that light rail would ease congestion and that it is an important element of the CRC project. Light rail opponents (four comments) cited concerns about the high cost of constructing the system and doubt that ridership will be high enough to offset the operation costs. Two additional commenters said that, although they supported light rail, they were concerned that there is not enough political support or funding for it at this time.

Process

Comments about process covered a wide range of topics. A few commenters expressed frustration that citizens will not have a chance to vote on whether the bridge is tolled. One commenter asked why the project team is considering reconstructing the interchange at Columbia Boulevard since they were "changed in the last 10 years." Another commenter asked why the current bridges will be replaced when the Washington State Department of Transportation inspection report states that the current bridges have a "life span of approximately 10-20 years."

Tolling

In May, four comments indicated support of tolling, one of whom suggested that tolls be high enough to eliminate nearly all discretionary trips. Twelve comments indicated opposition to tolling, with concerns ranging from a perceived financial burden on low-income populations and commuters, to potential confusion among tourists about how to pay the toll in the absence of toll booths.

Funding and Financing

Funding and financing comments included concerns that the project costs are too high. Some commenters suggested ways to reduce the cost of the project, such as eliminating light rail, reducing the number of lanes on the bridge, and focusing on the functionality of the bridge rather than the aesthetics. Other commenters stated that the federal government should pay for a majority of the Washington project because the project will benefit citizens outside of the region.
