**Exhibit B-2a. Proposed Permanent Property Impacts, Marine Drive Interchange for LPA Option A - East Side\***





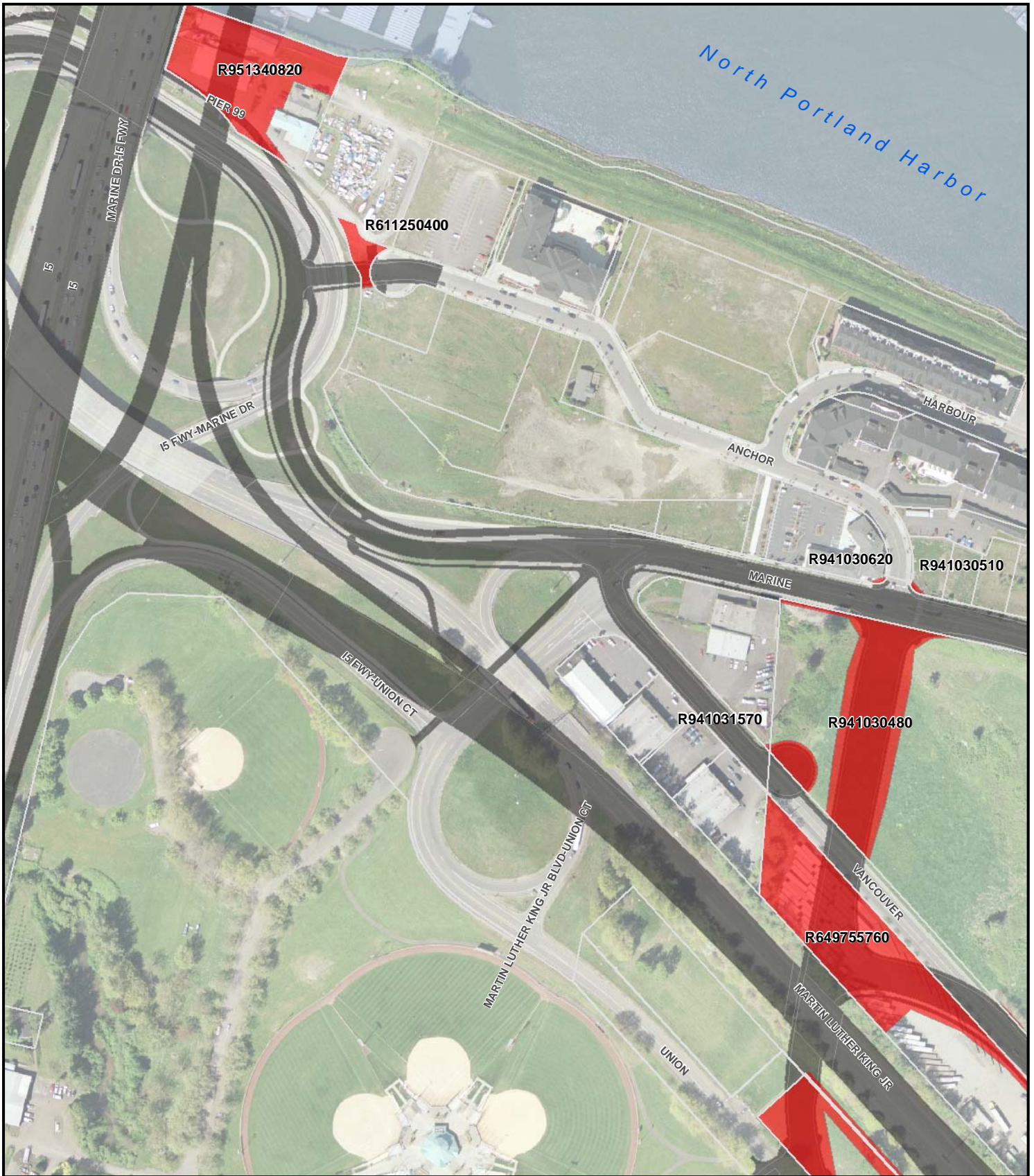
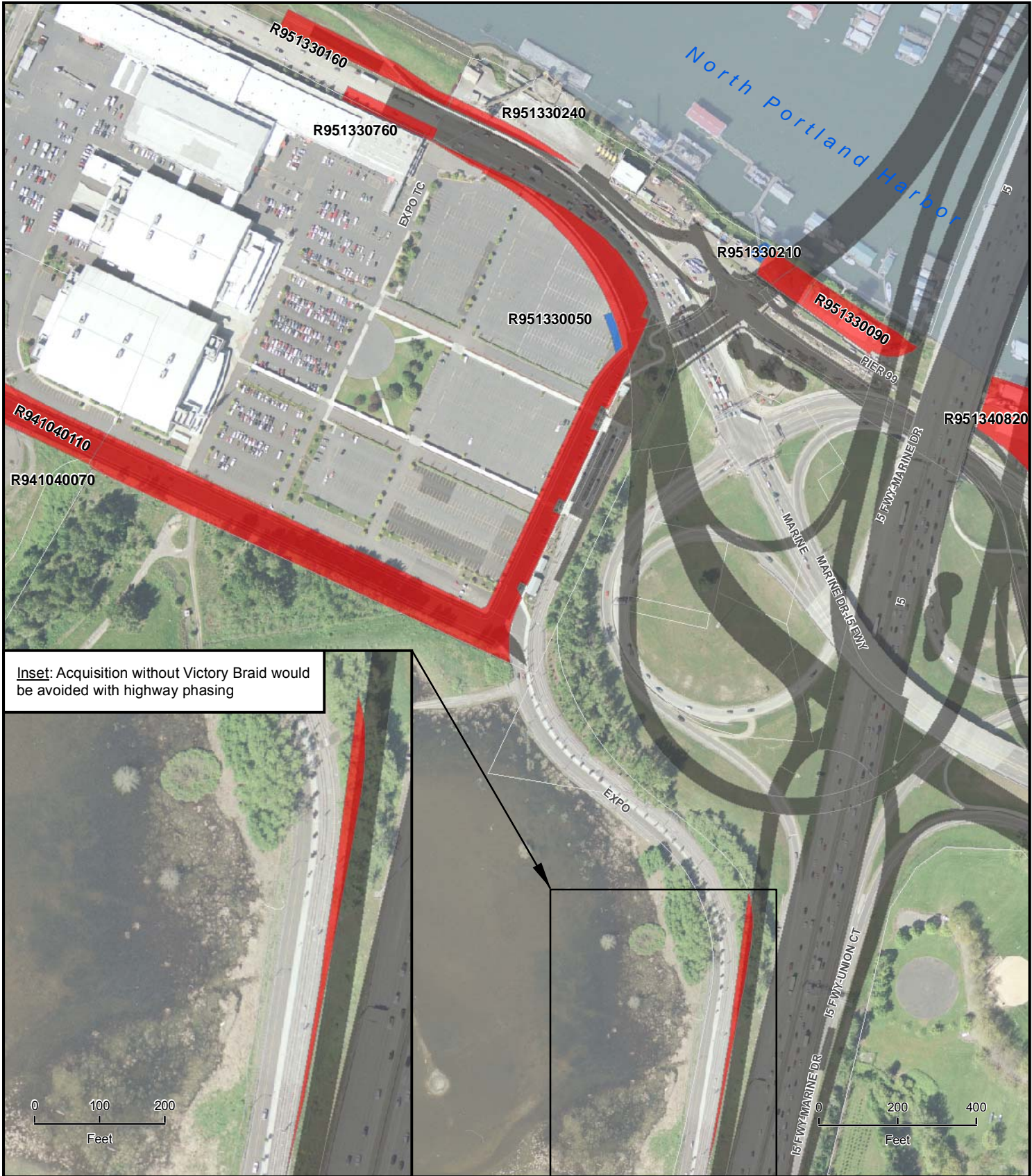


Exhibit B-2b. Proposed Permanent Property Impacts, Marine Drive Interchange for LPA Option B - East Side\*



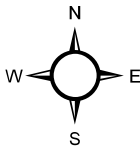

**Exhibit B-3a. Proposed Permanent Property Impacts, Marine Drive Interchange for LPA Option A - West Side\***

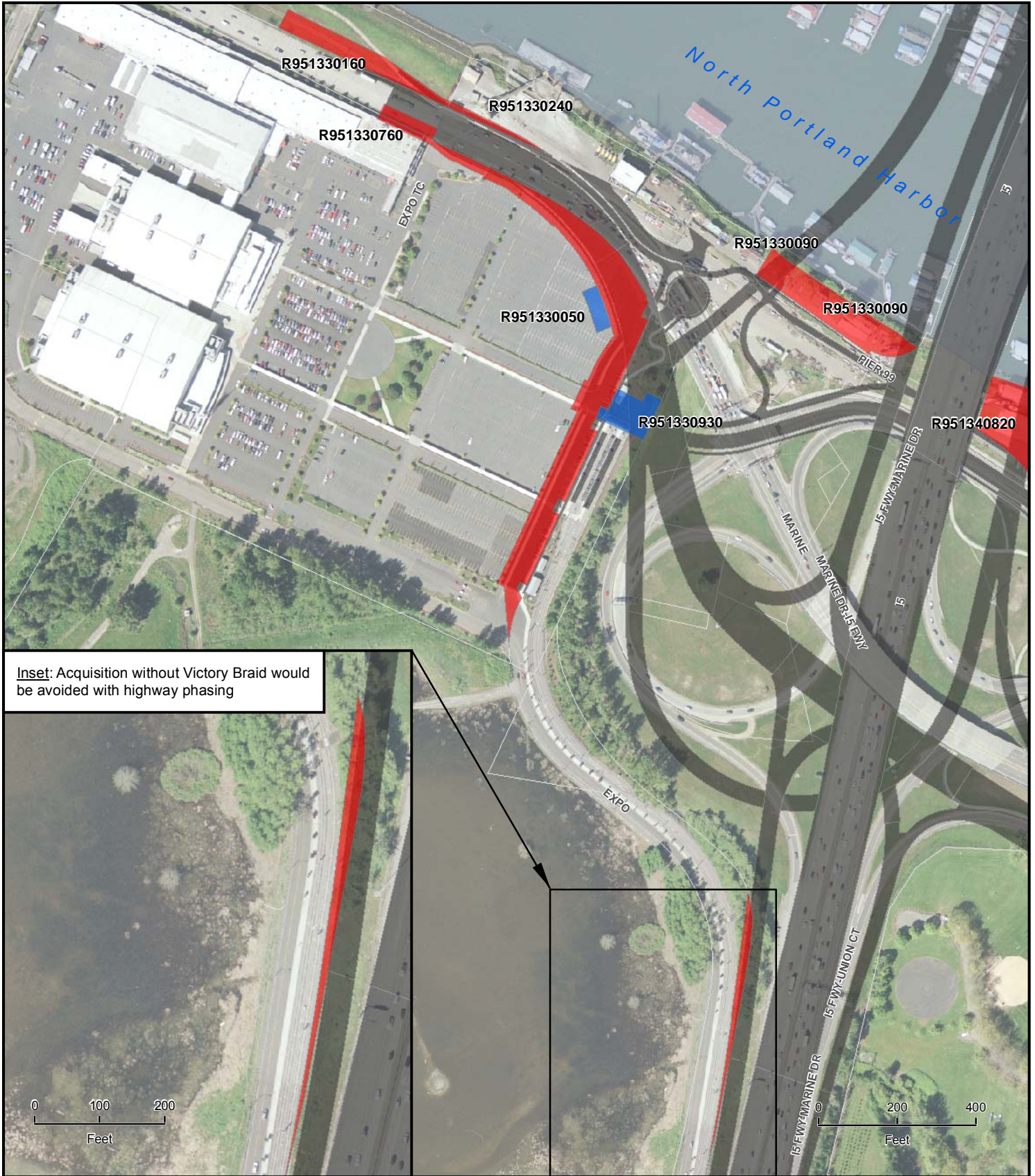

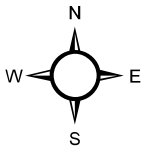

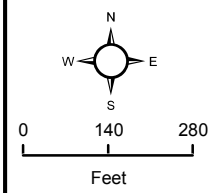

**Exhibit B-3b. Proposed Permanent Property Impacts, Marine Drive Interchange for LPA Option B - West Side\***









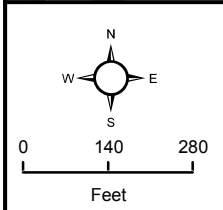
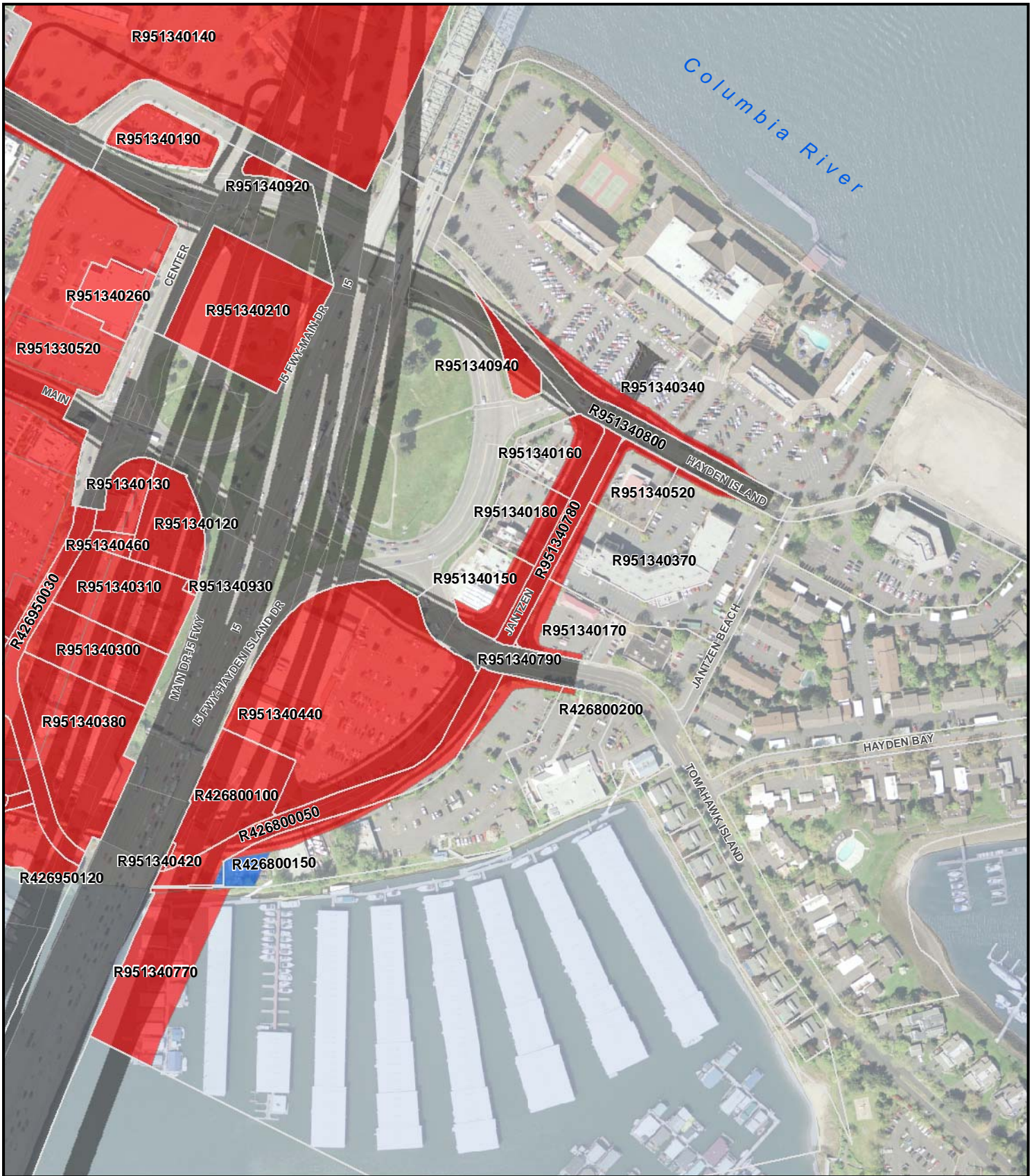

**Exhibit B-4a. Proposed Permanent Property Impacts, Hayden Island Interchange for LPA Option A - East Side\***







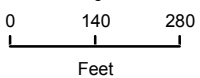
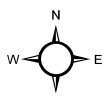

Exhibit B-4b. Proposed Permanent Property Impacts, Hayden Island Interchange for LPA Option B - East Side\*







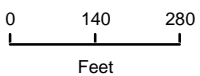
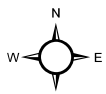

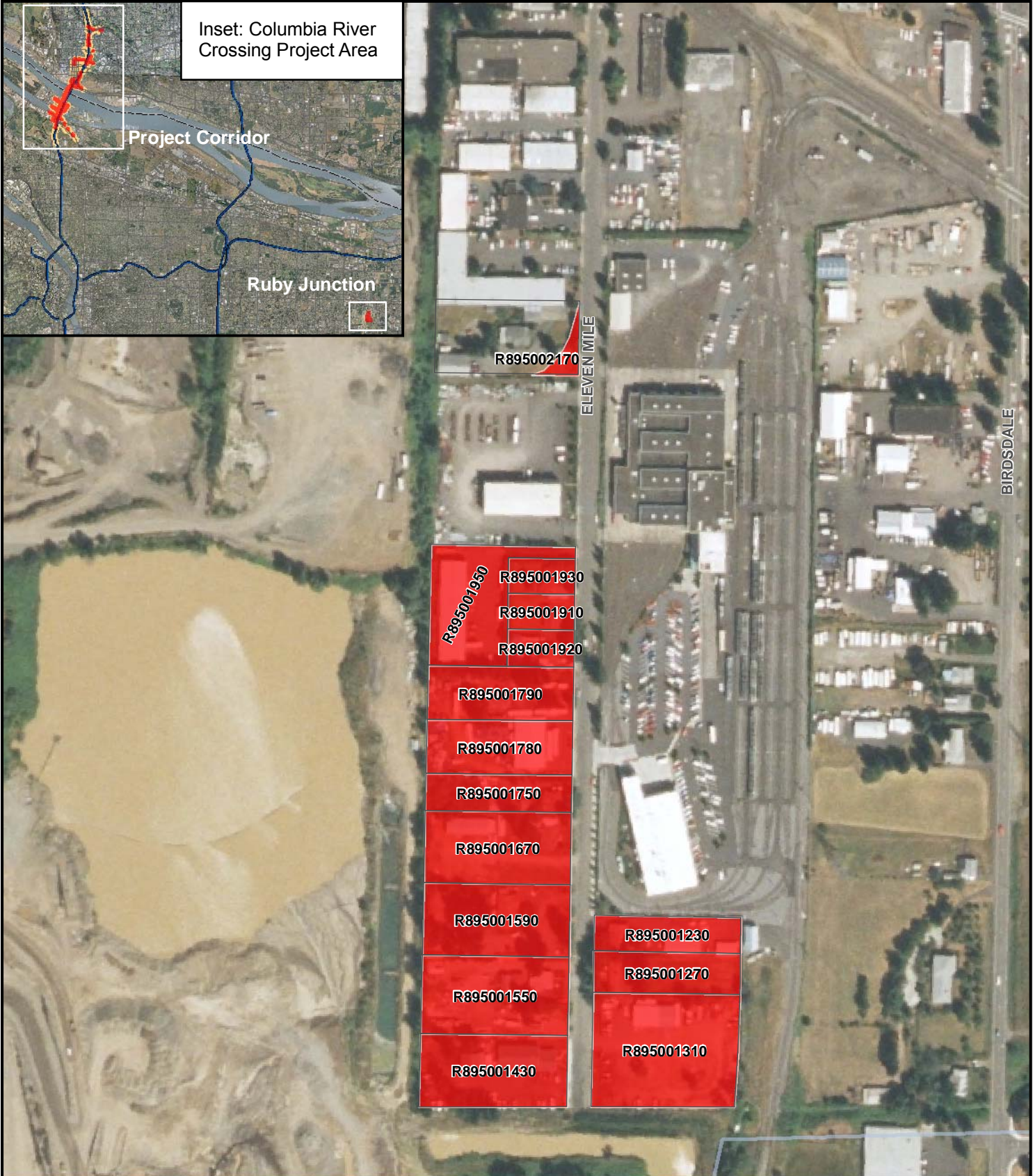

**Exhibit B-5b. Proposed Permanent Property Impacts, Hayden Island Interchange for LPA Option B - West Side\***









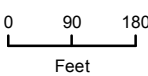

Exhibit B-9. Proposed Permanent Property Impacts - 13th Street to 17th Street\*



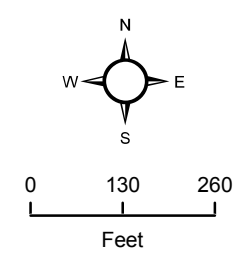

Exhibit C-2a. Proposed Temporary Property Impacts, Hayden Island Interchange for LPA Option A - East Side\*







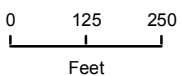
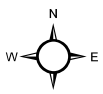


Exhibit C-2b. Proposed Temporary Property Impacts, Hayden Island Interchange for LPA Option B - East Side\*

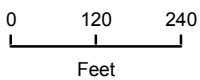

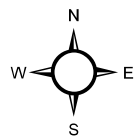
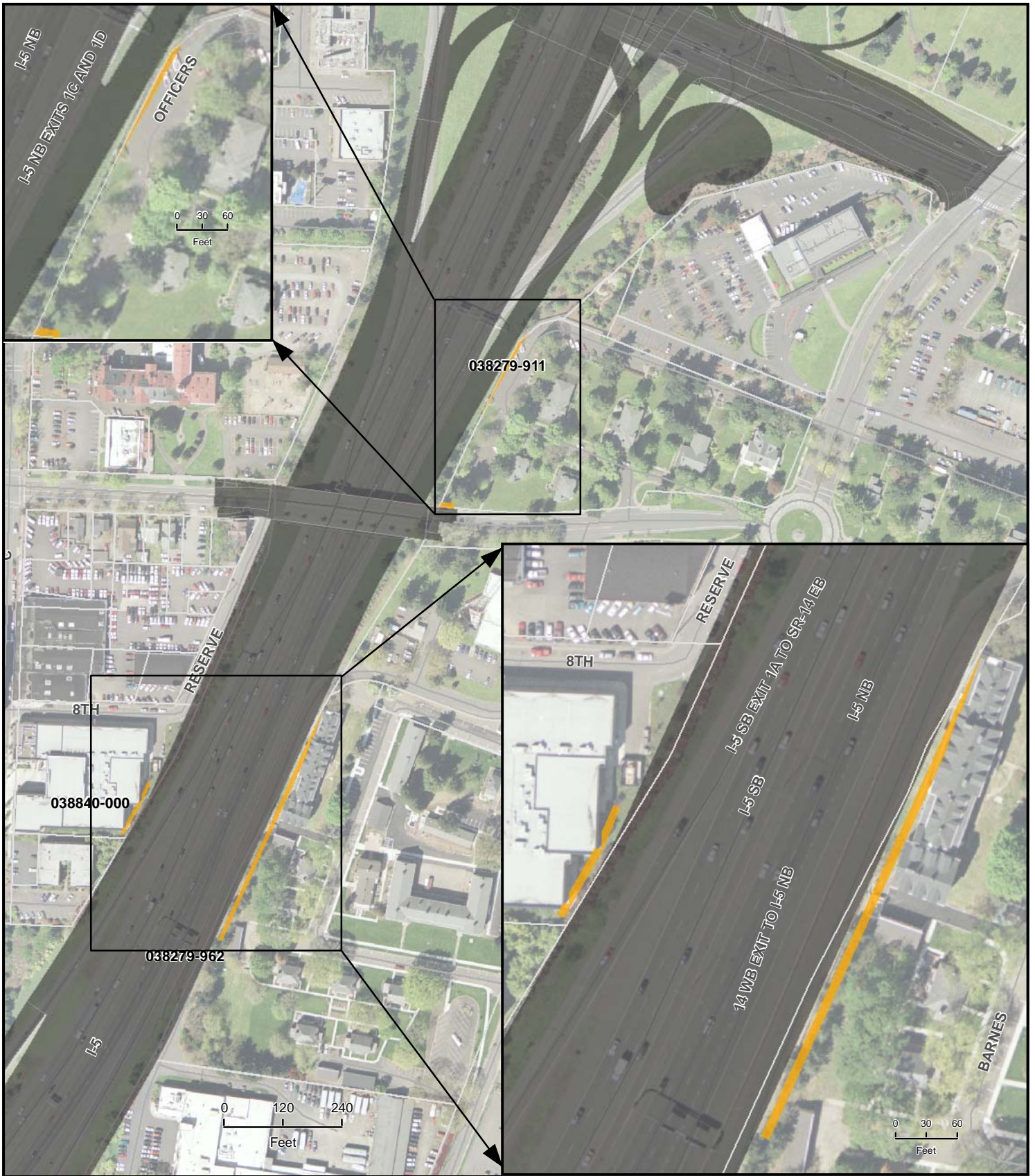
**Exhibit C-4. Proposed Temporary Property Impacts - SR 14 Interchange\***

Exhibit C-11. Proposed Temporary Property Impacts - 29th Street Overpass to SR 500 Interchange\*

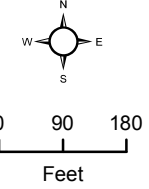

Exhibit D-4. Proposed Permanent Property Impacts, TriMet Ruby Junction Maintenance Facility, Gresham, Oregon





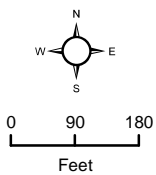
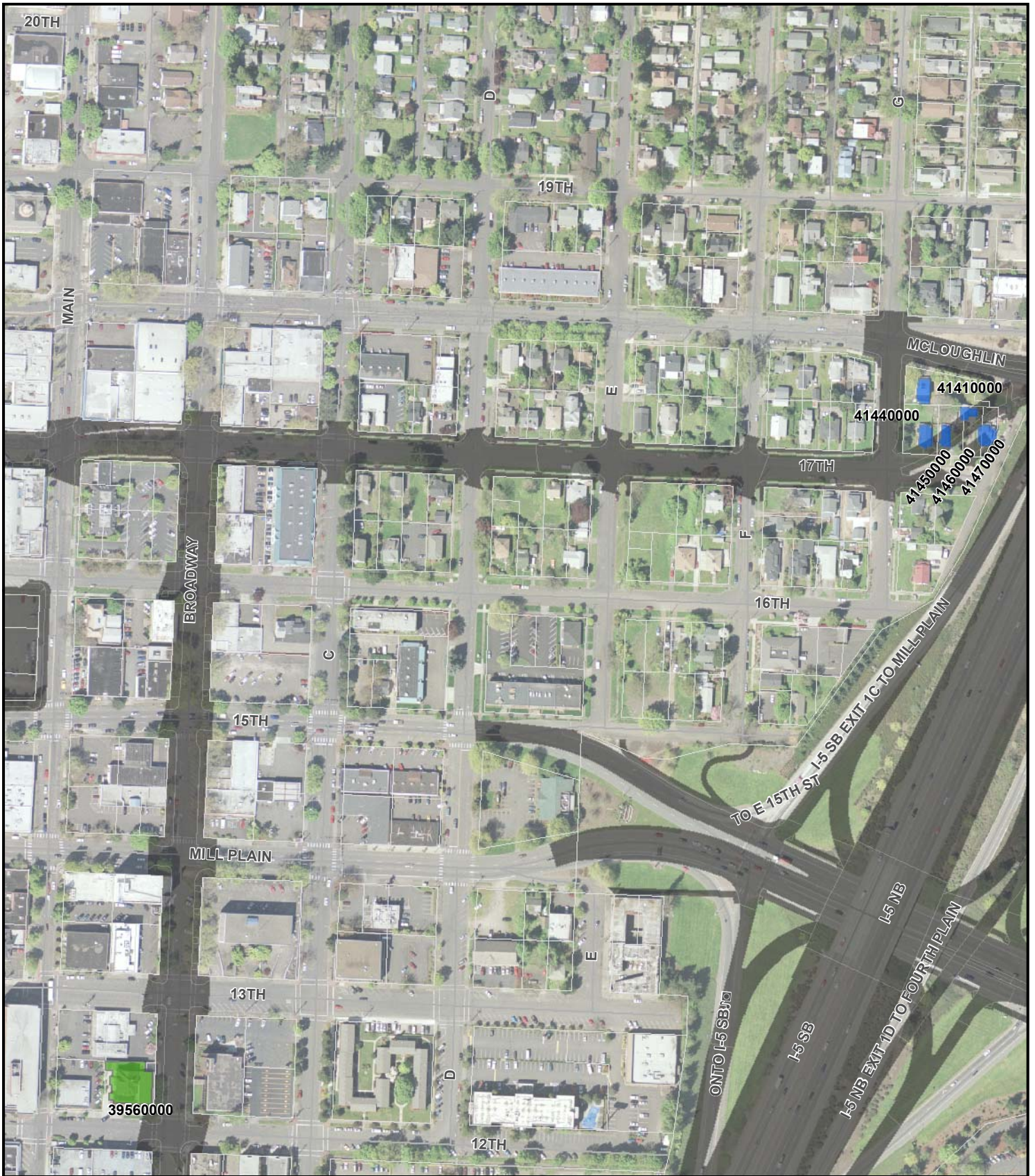

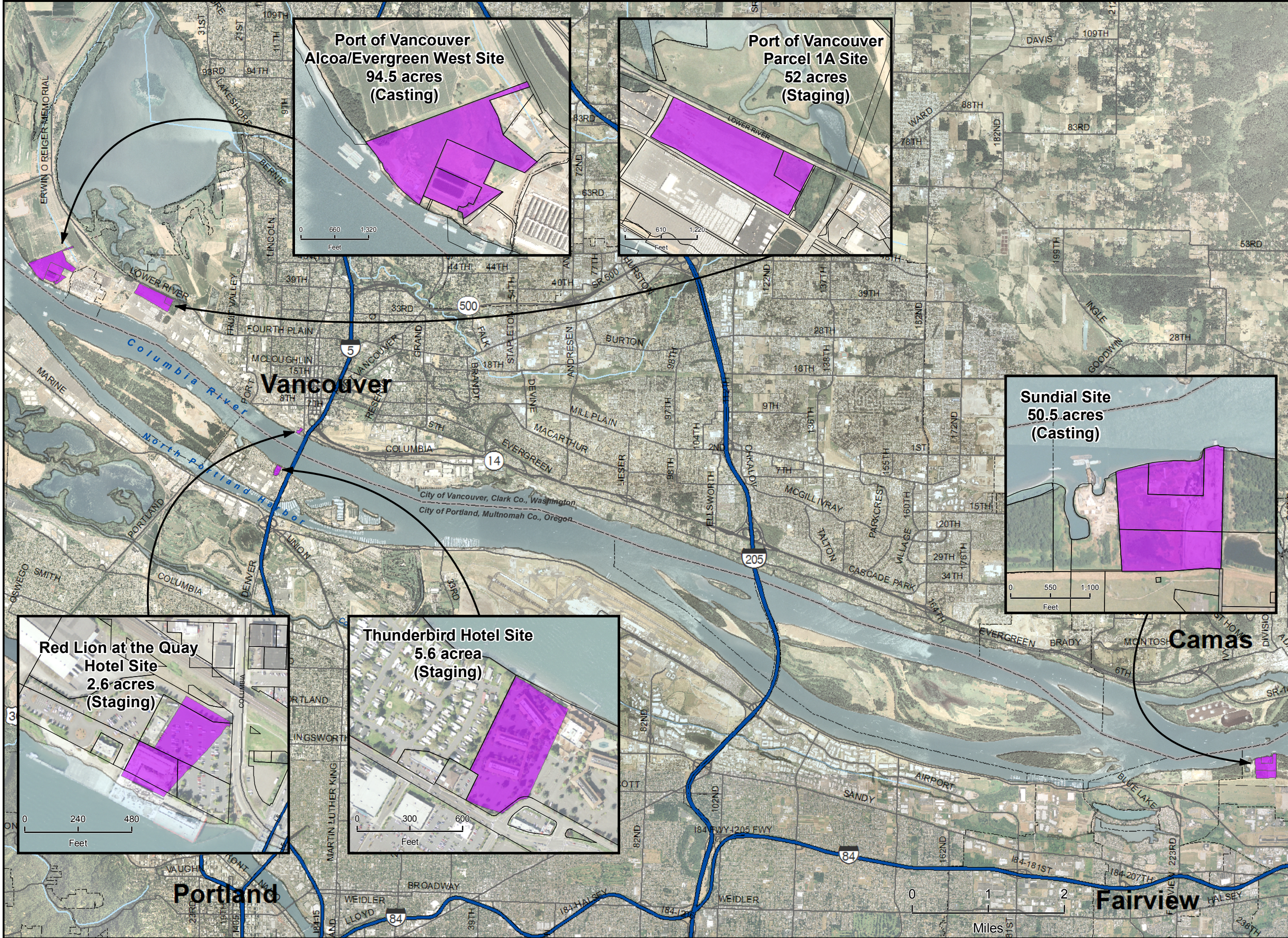
