Once we have received this hammer, and the testing on the bubble systems done, we will mobilize to the jobsite. We are planning on getting towed to the jobsite after lunch (or sooner, if possible).

We will have the bubble system ready for testing by 830AM on Thursday (2/10). We will do the testing at the Tidewater Barge Lines dock. Please have your inspectors show up at the Tidewater dock for witnessing (if required).
