Hi Vernon,

This is actually in reference to RFI #2, Surveying Question.

Page 91 of the Contract Special Provisions requires WSDOT to provide control data to the contractor which we have done in Serial Letter #7 dated 1/27/11. Any surveying required for setting and monitoring the pile locations is the responsibility of the contractor under bid item 9, Structure Surveying. WSDOT will not provide a survey "baseline" as requested.

The location that you indicate your control points will be on is at the Quey hotel/restaurant or Port of Vancouver property which we do not have right of entry for and you will not be allowed to use this location.

An option would be to use control points 3070 and 2032 shown on sheet 4 of 14 of the control data sent to you with Serial Letter #7. I have also shown the approximate location of control points 3070 and 2032 on the attached map. Control points 3070 and 2032 are within public right of way and doesn't require a right of entry for you to perform your surveying. If you plan to have control points any other location than control points 3070 and 2032 please check with our office to make sure we have right of entry permits before entering property or doing any work. If you have any questions please let me know.
